I actually called this number back and a male answered stating "hello". I asked to speak with Agent Carter (see dispatch notes below) and he stated speaking. I confirmed again asking Is this agent Carter from the FBI? And he said yes it is. I asked for his first name and he asked why I was calling? I explained that someone from this phone number contacted our dispatch center identifying himself as an agent from the FBI wishing to speak with someone from internal affairs. I told him that I am the undersheriff and handle those issues for the Sheriff's Office, asking how I can assist him? The male sounds nervous and tells me he has contacted the Governor and a Senator already and it has been handled. I told him that I need to confirm his identity with the FBI before I release the phone call – and he abruptly hung up ending my call with him.

You may wish to forward to FBI as I strongly doubt he is an agent, and they may like to know who is impersonating them to other LE agencies.

DI Ledvina – can you see if we can located these calls coming into dispatch for the FBI is they want to listen.
