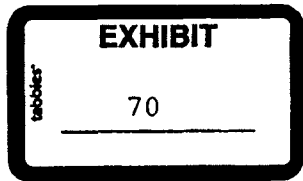


Dear Mr. Kirby:
